This is in reference to above subject, it is submitted that Kendriya Vidhyalay-01, Shahibaugh School Main building and Primary Red Building is found structurally safe on visual inspection as no significant structural reports were noticed inbeams & columns.

However following points need urgent attention as it may risk the structural safety of building.

Main School Building :-

- 1) Dampness on the walls at many places.
- 2) Leakages observed in toilet, Bathroom area resulting in falling of plaster / concrete patches.
- 3) Cracks are seen on R.C.C. vertical chhajja fins and RCC columns at many places. which result in falling of concrete lumps if left unattended.
- 4) RCC terrace water tanks are damaged. Concrete covers are falling down.

Preliminary estimate for these work has alredy been submitted.

Primary Red Building :-

Mangalore tiles & wooden battens in roofing at many places are broken / disturbed resulting in seepage at many places. Some cracks / Peeling of pointing work are observed at various places in brick work which require immediate attention.

1) Main Building:

It is learnt that the age of main building is approximate 35 years. A renovation work has been done recently in the building & during the work it was observed that some structural members have developed cracks, columns of the shafts had vertical cracks. During the dismantling of roof waterproofing, it was observed that the slab concrete cover was peeling off. Such cracks wherever found were suitably repaired.

At present, as per the visual inspection, structure doesnot show distress or sagging. However keeping in view of the age of the building, it is recommended that structural audit from a Government engineering college or Institute of repute may be carried out by you, to assess the structural safety of the building.

2) Primary Building:

It is a very old heritage building with masonary load bearing structure with steel structural members retrofitted. As per the visual inspection the building doesn't show distress or sagging.

However keeping inmind the age of the building, structural audit for this building is also recommended
